ECONOMICAL DATA ABOUT BRAZIL

Brazil covers an area of 3.275.510 square miles and ranks as the fourth largest country in the world, only after China, the United States and Canada.

It is larger than the United States, not including Alaska, and slightly larger than the greater part of Europe lying east of France.

It measures 2.691 miles from north to south, and has a seacoast on the Atlantic of 4.060 miles.

CONSTITUTION AND GOVERNMENT

According to the Constitution adopted by the National Congress in February 24th 1891 the Brazilian Nation is constituted as the United States of Brazil, comprising twenty States, one Federal District and the Territory of the Acre, acquired in 1903 by treaty with Bolivia.

The States forming the Federal Union were provinces under the Empire. They are autonomous, being administered at their own expense, without any interference from the Federal Government, except as under the Constitution, that is, for defence, for the maintenance of order and the execution of the federal laws.

The Federal Government reserves to itself the control of the Army and Navy; levies customs-duties on imports, has the exclusive right to establish banks of emission, runs the postal service and controls the ports and coastal shipping services, currency, weights and measures. To it falls the power of making treaties and conventions with foreign nations;



it equally controls all matters regarding naturalization and navigation of rivers flowing through more than one State, as well as those of a national character.

The States have the power to levy export duties.

The legislative authority is exercised by the National Congress, with the sanction of the President of the Republic. Congress consists of the Senate and the House of Deputies, meeting annually on May the third. Each of the States sends three members to the Senate, being considered, for this purpose as a State, the Federal District; their mandate is for nine years, one third of the Senate being renewed every three years. The House of Deputies consists actually of 212 members elected by direct vote for three years, there being one deputy to every 70,000 inhabitants, no State however having less than four representatives. This proportion was established in 1891, when the total population of Brazil was 16 millions; the number of representatives in the lower House has not been increased since then, though the population, being actually about 32 millions, has doubled.

The executive power is vested in the President, elected for a period of four years by direct vote of the people, suffrage being universal, that is, every citizen, 21 years old, being able to read and write, having the vote. The President is assisted by seven Ministers of State, whom he appoints at his choice.

CLIMATE

Brazil is situated in the southern hemisphere, and may be divided into three meteorological zones:

First: — The tropical zone, which embraces the northern part of the country from 2° N. to 10° S., is comprised by the States of Amazonas, Pará, Maranhão, Piauhy, Ceará, Rio Grande do Norte, Parahyba, Pernambuco, Alagoas, a small portion of Goyaz, Matto-Grosso and Bahia. This zone has a mean of temperature of 77° F.

Second: — The subtropical zone, embracing that part of the country from the 10° to the 23° S., comprises the States of Sergipe, Bahia, Goyaz, Espírito Santo, Rio de Janeiro, Minas Geraes, Federal District, almost

the whole of Matto Grosso and the western part of São Paulo, the mean temperature of which is 75° F.

Third: — The temperate zone extends from the tropic of Capricorn to the southern boundaries, comprises the southern part of the State of São Paulo and the States of Paraná, Santa Catharina and Rio Grande do Sul, the mean of temperature of which is 63° F.

In this vast area of Brazil every kind of climate is found, because there are no extremes of either heat or cold.

POPULATION

By the last federal census, taken in September 1920, the population of Brazil was found to be 30.635.605 inhabitants; this number is estimated at 36.870.972 for 1926.

The following table shows the increase in the population since 1808, when the total number of inhabitants did not exceed 4.000.000.

The mean average increase figures ascertained for the years 1900 to 1920, indicates that in 1944 Brazil will have about 61.371.000 inhabitants. This figure in itself is a demonstration of a flattering increase, considering

that a period of 25 years for the population to double in is held to be a significative symptom of development, only to be found in countries whose demographic situation is one of exceptional prosperity.

Up to the present moment the current of immigration, which has been relatively small, has been directed entirely to some of the southern States. It is more than certain that once this current is diverted to a certain extent to the remaining units of the Republic, the proportional increase of the population will be much higher, though it is here of interest to note, that it is not only in the States which have received the benefits of immigration, that are found the highest coefficients of increase in the number of inhabitants.

Decree n. 5.108, dated 18th December 1926, altered the monetary system of Brazil. Gold weighed in grammes is adopted as the standard of Brazilian currency, and shall be minted in coins containing 900 parts of gold, and 100 parts of alloy.— All the paper money at present in circulation, amounting, to 2.569.304 contos shall be converted into gold on the basis of 200 milligrammes (nine parts fine gold) per milréis.

The approximate value of one milréis (1\$000) will be, according to this Decree, $5\frac{11}{128}$ pence.

The revenue in 1926 was of £ 795.864 and expenses amounted to £ 825.610.

Of 37 wireless telegraph stations, 23 belong to the Ministry of Communications and Public Works, 11 to the Ministry of Marine and 7 to the Ministry of War.

SHIPPING AND NAVIGATION

According to Brazilian law, the commercial coastwise navigation service is handled by national ships exclusively.

The mercantile navy at the end of 1917 amounted to 405 steamers and 54 sailing vessels of 100 tons upwards. The gross tonnage of the steamers was 377.447 and the sailing vessels 17.920.

At the end of 1926 there were 582 steamers of 618.588 gross tons and 107 sailing vessels of 41.535 tons.

The States which have the greatest railway mileage are: Minas Geraes with 4,758 miles; São Paulo, 4,227 miles; Rio de Janeiro and Federal

District, 1.763 miles; Rio Grande do Sul and Bahia with 1.882 and 1.218 miles respectively, giving a total of 13.848 miles, equivalent to 71 % of the railway mileage in Brazil.

Brazil has railroad communication with Argentina and Uruguay.

The principal railway is the Estrada de Ferro Central, a Government property, the total length of the line in operation being 1.804 miles. This network connects the city of Rio de Janeiro with the States of São Paulo, Minas Geraes and Rio de Janeiro. The number of passengers transported on its trains, including suburban traffic, was 69.131.297 in 1926. The tonnage of freight handled during the same year, was as follows: fast freight or express 289.754 tons, regular freight 3.236.039 tons and live stock 610.863 head. Receipts, in 1926, amounted to 131.660 contos or £ 3.211.220.

Of the railways existing in Brazil the Federal Government owns 11.613 miles, while 2.976 miles of road are operated under federal concession and 4.877 under State concession.

According to the report presented by the Committee appointed by the Ministry of Communications, the value of the railways under Governmens ownership was, in 1922, 2.075.793 contos, or £ 61.895.403; the railwayt of greater value are the following:

In November 1914, Brazil began the exportation of chilled and frozen meat, which has had an unlooked for development, as can be seen from the figures of a special table published at page 48.

MINERALS

Brazil possesses vast richness in minerals of all kinds, but their exploration is still to be begun, very few of the mines existing in the country as yet being worked.

The data, regarding the exportation of minerals, given here, show that the growth of this trade has been slow. Manganese occupies a

foremost position in this class of products, and the figures for its exportation, in the last fourteen years, appear in a special table amongst the chief products exported, at page 52.

The mineral occupying second rank was gold, but its export is prohibited since 1918. The average annual exportation of gold for the period from 1903-1917 was 132.033 troy ounces, of a value of £ 444.780, according to the following *data*:

There is probably no other country in the world where conditions are more favourable to agricultural development than in Brazil. Its soil is capable of producing nearly all plants which grow in temperate, sub-tropical and tropical regions.

Brazil is the biggest coffee producing country, supplying $\frac{3}{4}$ of the world's consumption of this commodity. It comes in second place as a producer of cocoa and Indian-corn; in third for tobacco; for cotton it occupies the fifth place, being in eighth for rice and in tenth for wheat and potatoes.

As the Bureau of Statistics has not yet completed its figures of the industrial census concerning the output in 1920, the data, given below, of the production of some of the national factories, are taken from the statistics of the consumption tax, to which some of the industries are subject.

Looking at this table, which specifies the figures for the years 1913, 1916 and 1921, the development, which certain industries have undergone, is patent. It is, however, important to remember, when examining these

figures, that only about 50 % of the total industrial establishments in Brazil appear, as only some industries which pay the consumption tax, are therein enumerated.

PRICES OF LAND IN THE COTTON GROWING STATES OF BRAZIL

The price of land, in the various cotton growing States of Brazil, varies according to their locality and the variety of culture. Land situated near the railways, in the proximity of maritime or fluvial facilities, and in the vicinity of consuming markets and populated centres is, of course, more valuable than land not having these advantages.

Pará — The vacant lands of great extension are sold by the State in lots of 100 hectares at 1\$ per hectare, for such areas, and at an additional \$100 per hectare for every 1.000 hectares or fraction thereof, when situated near the railways. These prices suffer a reduction of 50 % when the land is situated in unexplored regions, in the vicinity of rivers interrupted by rapids, or at more than six kilometers distance from the navigable rivers or railroad.

In the colonial nuclei, land is sold at from 15\$ to 20\$ per hectare. In the forest region the price varies from 5\$ to 10\$ per hectare.

Piauhy — The land in the northern part of this State is more valuable, as this is the more populated region and the largest productive centre. In second place comes land on the river Parnahyba and thirdly, that situated in the southern and central regions of the State.

Maranhão — Here, land is not acquired by hectare or *alqueire*, but by a *unit called data* and *posse*. *Data* has an area about 13.068 hectares.

As the sale of lands in such large lots is difficult their owners divide them up into *posses* of which sometimes 20, sometimes 50 go to the *data*.

The price of one *data* in the south is of 20 contos, one *posse* being valued at 1 conto of réis.

In the northern part, one *data* is worth about 40 contos, and on the margins of the Parnahyba the price goes up to 100 contos, being from 15 to 30 contos in the centre.

Ceará — The price of land, in this State, per hectare varies from 60\$ to 500\$ on the seacoast; 200\$ to 800\$ in the mountainous region and from 10\$ to 30\$ in the plateau.

Rio Grande do Norte — The following prices reign here: on the coast from 500\$ to 1 conto per hectare; in the *sertão* (interior), specially in the region of Seridó, at 900\$ per hectare; prairie land varies from 20\$ to 350\$ per hectare.

Parahyba do Norte — Cotton growing lands in this State range at prices from 150\$ to 200\$, on the coast, from 200\$ to 300\$ for grassland and from 400\$ to 600\$ in the *sertão* or interior.

Pernambuco — This State may be divided into three parts: coast, forest and highland, with the following prices: 50\$ to 500\$ on the coast, 150\$ to 1 conto for forest and low shrub country, and 10\$ to 150\$ in the highland.

Alagoas — Prices range from 50\$ to 200\$ per hectare.

Sergipe — The more valuable lands are situated on the margins of the river São Francisco and in the valleys of Japaratuba and the heights of Cotinuiba.

The argillaceous and argillaceous-silicious lands are sold at 30\$ to 50\$ per *tarefa*.

Sand soils at 20\$ to 50\$000.

Bahia — This State is divided into three agricultural regions: coast and southern or forest region, grassland and highland. Vacant lands are sold by the State at 3\$ to 10\$ per hectare. In the southern or forest region prices range from 400\$ to 500\$ per hectare; on the coast, from 50\$ to 500\$ and for grassland, they vary from 3\$ to 50\$ per hectare.

Minas Geraes — In the central region, where land is more valuable, prices range from 200\$ to 250\$ per hectare; in the "Triangle" region, from 100\$ to 600\$ per hectare; and in the prairie lands from 50\$ to 200\$000.

São Paulo — Four agricultural regions may be distinguished in this State: coast, northern region, prairie region, and red earth region. On the coast, prices go from 15\$ to 200\$ per hectare; in the north, from 35\$ to 350\$ per hectare and, in the prairie region, from 15\$ to 100\$000. In the red earth region, the minima prices are from 20\$ to 50\$ and maxima from 180\$ to 600\$ per hectare.
